BECAUSE THERE WAS SUCH AN INCREASE IN FREE FOOD AVAILABLE TO THE AGENCY PARTNERS SALES TO THEM WERE DOWN 10%. OVERALL SATISFACTION WITH THE AGENCY TEAM BY PARTNERS WAS HIGH.
